

World Topics

1. ICH Assembly Meeting

The Assembly of the International Council for Harmonisation (ICH) met in-person on the 15 - 16 November 2022, in Incheon, Republic of Korea in parallel of meetings of ten Working Groups, and preceded by meetings of the ICH Management Committee and the MedDRA Management Committee.

The meeting provided an important opportunity to advance work of ICH's thirty-three Working Groups and key activities including training.

The ICH Assembly also welcomed DPM, Tunisia as a new ICH Observer, bringing ICH to a total of 20 Members and 36 Observers.

The Consumer Healthcare Products Association (CHPA) released findings from its 2022 Over-The-Counter (OTC) Value Study, once again showing that self-care with OTC medicines not only benefits individuals but also benefits the entire healthcare system

on 1st december 2022. This year's study found that on average, every dollar spent on OTC medicines saves the U.S. healthcare system \$7.33, resulting in an overall annual savings of \$167.1 billion.

3. EMA

EMA recommends withdrawal of pholodine medicines from EU market on 2nd December 2022.

EMA's safety committee, PRAC, has concluded its review of medicines containing pholocodine, which are used in adults and children to treat non-productive (dry) cough and, in combination with other active substances, for the treatment of symptoms of cold and flu, and has recommended the revocation of the EU marketing authorizations for these medicines.
